

## RELEASE AND WAIVER OF PUBLICITY & LIABILITY

On behalf of myself and/or the minor set forth below, and my personal representatives, heirs, next of kin, executors, representatives, assigns and administrators (collectively, “I,” “me” or “my”), I ACKNOWLEDGE THAT MY PARTICIPATION IN LESSONS, EVENTS, AND OTHER ACTIVITIES, USE OF EQUIPMENT, AND ACCESS TO FACILITIES (“ACTIVITIES”) AT OR OF GUITAR SHED LLC IS VOLUNTARY AND MAY INVOLVE RISK OF BODILY INJURY, DEATH OR DAMAGE TO PROPERTY.
